**LODGING:** (See rules and regulations regarding cancellation policy)

<b>LODGE:</b>	<b>\$ 60.00</b>	Per room per night (An additional charge of \$5.00 per room per night will be added if extra linens are provided)
<b>*DORMITORY COTTAGES:</b>	<b>\$ 15.00</b>	Per person per night – Linens are <u>not</u> provided ( <u>no</u> pillows, blankets, sheets, towels)
<b>*BONAR COTTAGE:</b>	<b>\$ 25.00</b>	Per person per night with linens
	<b>\$ 20.00</b>	Per person per night without linens

- A minimum usage fee of \$150.00 per night for each dormitory cottage and \$200.00 per night for Bonar Cottage is required.

**MEALS:** (For groups of 50 persons or less, add \$2.00 per meal per person)

<b>Breakfast:</b>	<b>\$5.00*</b>
<b>Lunch:</b>	<b>\$6.00**</b>
<b>Dinner:</b>	<b>\$9.00</b>

\*A continental breakfast can be served instead of a traditional breakfast for a cost of \$4.00 (\$5.00 if catered to the lodge for no less than 25 persons) which consists of muffins, bagels, juice, cold cereal, milk and coffee.

\*\* \$2.00 will be added to lunch or dinner price per person for salad bar.

**Please note:** Final number for meals must be guaranteed 1 week in advance of arrival. A minimum guarantee of 25 persons per meal is required. Meals cannot be canceled altogether less than two weeks prior to the event.

Snacks can be provided for your group at morning, afternoon or evening for additional charge. (See attachment)

Banquets (buffet style only) can be served at the lodge or dining hall. Contact our office for choice of menus and prices.

Special menus are available upon request. Additional charges may apply.

**DEPOSIT:** A non-refundable deposit of \$250.00 is required within 15 days of receipt of contract (\$1,000.00 deposit for summer camps of 4 nights or longer). This deposit will be applied to the group's final bill. Groups that cancel less than 30 days prior to arrival (or 90 days for summer camps) are subject to a cancellation fee equal to the first night's reserved lodging.

**TAX:** All charges are subject to WEST VIRGINIA CONSUMERS SALES TAX. If you are tax exempt, you must furnish us with a West Virginia tax exemption certificate yearly.

In addition, all Lodge and Dorm charges are subject to 6% Hotel/Motel Occupancy Tax regardless of exempt status.

ALL PRICES ARE SUBJECT TO CHANGE. A 60 DAYS' NOTICE WILL BE GIVEN.

**\*Room Rentals: Groups using 12 or more lodge rooms or cottages for accommodations will be provided one conference room at no charge. Charges for other reservations will be as follows:**

\*\* A special swim admission card may be purchased at the camp office or during pool hours. This card entitles children to 10 swim admissions for \$25.00 and adults to 10 swim admissions for \$35.00.

**Pool Use:**

We do not operate a concession stand, however, vending machines are available.

Groups who rent the pavilion may use the pool with the general public during public pool hours and must pay general admission to the pool.

The pool may be reserved for your group any day between 5:00 p.m. and 7:00 p.m. for the cost of \$150.00 for 50 people or less and \$30.00 for each additional 10 people.

**Pavilion Regulations:**

1. All groups wishing to schedule the picnic pavilion will be mailed a contract upon request. This contract must be completed, signed and returned to us along with the specified fee within 15 days of receipt to ensure reservation. Fee is non-refundable.
2. Each youth group must have adequate supervision at all times.
3. Groups scheduling the pavilion will be responsible for all damages to the pavilion property and grounds by members of their group. Charges will be based upon the cost of materials, labor and transportation.
4. Each group is responsible for clean-up of pavilion after use. Trash receptacles are provided.
5. **Gambling and the use of alcoholic beverages or illegal drugs are prohibited at the pavilion and grounds.**
6. Pavilion closes at dark.

**Ballfield:** The ballfield at the pool is available on a first come, first served basis, with resident campers in the lodge and or dorms having first refusal.
